



2020 – 2021 Frequently Asked Questions

What is the purpose of the Distinguished Teacher Review?

The Distinguished Teacher Review (DTR) is a component of the Teacher Excellence Initiative. The aim of DTR is to retain and reward our best teachers, inspire other teachers to grow, and raise the bar for effective teaching.

What is the purpose of the DTR Application?

The purpose of the DTR Application is to retain and reward teachers for the many roles they hold within and beyond the classroom. The application emphasizes three key levers of impact: leadership, lifelong learning, and contributions to the profession.

Eligibility

What is the 2020 – 2021 DTR Eligibility Criteria?

For this year ONLY, DTR eligibility will be as follows:

1. Round 1 will include teachers who are eligible based on their **2018-2019 TEI Scorecard**. Submission of a new application during the Round 1 window is **optional** and no teacher with current eligibility will be required to re-apply in 2020-2021.
2. Round 2 will include **teachers without 2018-2019 eligibility** who:
 - Are in the third year of service (Have 2 CYS complete),
 - Have prior TEI data (must have 2018-19 Evaluation Rating of Proficient I or higher. If not, will require ED approval.),
 - Receive half of required spots and extended observation completed by primary appraiser **before 01/29/21**,
 - Have a Summative Evaluation submitted by the primary appraiser with a **minimum criteria of 80 before 02/12/21** and must include review of any mid-year assessment data, and
 - Meets minimum requirements for student achievement/experience on the 2020-2021 TEI Scorecard.

If I meet DTR eligibility criteria, am I guaranteed a Distinguished Effectiveness Level?

No. Teachers who undergo the Distinguished Teacher Review must also earn an average evaluation score within or beyond the Proficient II Effectiveness Level range to earn a Distinguished Effectiveness Level (scores will not be averaged during the 2020-2021 school year).

Do I have to go through the Distinguished Teacher Review to earn a Distinguished Effectiveness Level?

Newly eligible teachers (i.e. DTR-eligible teachers with an Effectiveness Level below Proficient II) must undergo the Distinguished Teacher Review to receive an Effectiveness Level of Proficient II or higher. Teachers currently holding a Distinguished Effectiveness Level (Proficient II or higher) and DTR points do not need to submit a DTR Application to advance an Effectiveness Level.

If I currently hold a Distinguished Effectiveness Level, do I need to go through the Distinguished Teacher Review to remain a Distinguished teacher?

No. For Distinguished teachers who maintain DTR eligibility, DTR points will carryover for two years. Note: teachers' Effectiveness Levels will not decrease unless they earn a lower Evaluation Rating for four consecutive years.

Scoring

How many points are available to teachers through the DTR Application?

Starting in the 2018-2019 school year, teachers can earn up to 20 points on their DTR Application. Specifically, teachers may earn up to 8 points by demonstrating examples of their Leadership and up to 6 points by demonstrating examples of their Lifelong Learning and Contributions to the Profession, respectively.

How is my DTR Application score determined?

The DTR Application is scored by trained, TEI and DTR Certified, review teams. Each experience is individually scored using the DTR Rubric and assigned a performance level. Applicants are given the highest performance level based on individually scored experiences within each domain. Therefore, it is in an applicant's best interest to provide the strongest experiences within each domain. Teachers will receive the points earned from the review of their application on their DTR Snapshot by September 2021.

If I currently hold a Distinguished Effectiveness Level, will my DTR points carryover?

Yes. For teachers who maintain DTR eligibility, DTR points will carryover for two years only. After DTR points have been applied to teachers’ Scorecards for three consecutive years, teachers must undergo DTR again to earn DTR points.

If I am eligible to use carryover points and elect to submit a DTR Application early, will I receive the better of the two scores?

No. Teachers will receive DTR points based on his or her *most recent* DTR Application.

I am currently DTR-eligible with points available for carryover. Will I need to re-apply in 2020-2021?

No teacher with DTR-eligibility in 2019-2020 will be required to re-apply in 2020-2021. Teachers may continue to carryover points up to three times before re-applying while eligibility is maintained. See the table below.

Will the 2019-2020 school year be used to determine the total number of Tier 1/HPC points on my 2020-2021 TEI Scorecard?

Yes. While scorecards will not be produced for 2019-2020, teachers’ Tier I/HPC service will be credited based on 2019-2020 campus assignment.

Application

What types of experiences should I include in the Leadership domain of the DTR Application?

In the Leadership domain, a Distinguished Teacher serves as a role model and leader for peers across the campus in formal and informal settings, proactively setting high standards and demonstrating commitment that accelerates the goals of the school. Examples may include mentoring new teachers, coordinating new teacher support at the campus, or demonstrating initiative in starting a new campus system. Experiences are differentiated across performance levels based on the *strength of the outcome*. What types of experiences should I include in the Lifelong Learning domain of the DTR Application?

In the Lifelong Learning domain, a Distinguished Teacher initiates or seeks out multiple learning opportunities and applies learning successfully to improve individual and campus practice, showing commitment to team innovation and growth. Examples may include professional learning experiences such as personal research, formal training, or degree programs. Experiences are differentiated across performance levels based on the *outcomes* resulting from implemented new learning. What type of experiences should I include in the Contributions to the Profession domain of the DTR Application?

In the Contributions to the Profession domain, a Distinguished Teacher contributes to the improvement of instructional practice of other K-12 teachers and/or impacts K-12 education policy at the campus, district, state, or national level. Examples may include collaboration, development of resource materials, leading professional development, or participation in committees or groups that impact education policy. Experiences are differentiated across performance levels based on the strength of the outcome and scope of impact. All experiences must cite outcomes to meet the requirements for this domain. What is the deadline to submit a DTR Application for the 2020 – 2021 school year?

For teachers **with 2018-2019 TEI data**, the deadline to submit a DTR Application is noon on November 5, 2020.

For teachers **with no 2018–2019 TEI data**, the deadline to submit a DTR Application is noon on April 1, 2021.

Where can I find additional resources to assist me in completing the DTR Application?

When will I be notified if I earn a Distinguished Effectiveness Level?

Applicants will be notified of their Effectiveness Level based on the 2020 - 2021 school year via their Scorecard in September 2021.

How do I reach Exemplary II or Master teacher status?

To reach Exemplary II, an applicant must have served as an Exemplary I teacher for at least one year. The first Exemplary II teachers will be designated in September 2016. To reach Master teacher status, an applicant must have been rated at the Exemplary II level for at least two consecutive years and taught at a High Priority Campus (previously Tier 1 campus) as a Distinguished Teacher for a minimum of four consecutive years. The first Master teachers will be designated in September of 2018.

Is there a limit to the number of Distinguished Teachers that can be at one school?

No. There is no limit to the number of Distinguished Teachers there can be at one school.

Will my Round 2 2020-21 DTR Eligibility impact my salary and/or stipend eligibility for the 2020-21 school year?

No. 2020-21 Round 2 DTR Eligibility does **not** impact 2020-21 Teacher Compensation.
